NATIONAL MINORITIES IN THE FEDERATION OF BiH

When in 1990 Bosnia and Herzegovina became an independent state, the state of three constituent peoples, a lot of people remained nationally undefined. The normative acts on all levels classified the constituently undefined people in the category of **the others**. Since 1996 the idea emerged that those who did not belong to the constituent peoples should organize themselves into non-governmental organizations, that is, national minority associations. The Convention on Human Rights, signed by BiH, also stipulates the right of **national minority**. In **2003** the Parliamentary Assembly of Bosnia and

Herzegovina adopted the Law on Protection of Rights of National Minorities. This Law stipulates that Bosnia and Herzegovina protects the position and equality of members of 17 national minorities, such as: Albanians, Montenegrins, Czechs, Italians, Jews, Macedonians. Germans. Hungarians. Poles. Romanies, Romanians, Russians. Ruthenians. Slovaks, Slovenians, Turks and Ukranians. Any form of discrimination is prohibited on a national, ethnic, racial and language basis against the persons which belong to national minorities in BiH. The authorities should respect and protect, preserve and develop ethnic, cultural, language and religious identity of each member of the national minority who is a citizen of Bosnia and Herzegovina.

In **2008** the Parliament of the Federation of BiH adopted the Law on Protection of Rights of National Minorities in the Federation of Bosnia and Herzegovina. Aiming to protect the rights of national minorities, the Law established the Council of National Minorities of the Federation of BiH as an advisory body to the Parliament of the Federation of Bosnia and Herzegovina.

November 2009. following the public In the Decision was made announcement, on establishment of the advisory body to the Parliament of the Federation of BiH, the Council of National Minorities of FBiH. Based on the Decision, the Council was composed of 11 members of national minorities, and as representatives of all minorities have not been included, they are expected to consequently join the Council.

At the inaugural conference held on 15 February 2010, the Council elected the President and two deputies, passed the Statute, Rules of Procedure and appointed standing working bodies:

- Committee for Drafting and Implementation of the Council's Activity Program,
- Committee for Constitutional and L Affairs and Development and Protection of Rights of Members of National Minorities,
- Committee for Protection, Preservation and Development of Cultural, Educational and Language Identity of Members of National Minorities.

Both houses of the Parliament of the Federation of Bosnia and Herzegovina should approve the documents of the Council. The House of Representatives endorsed it, however, without any explanation the House of Peoples failed to do so, thus the work of the National Minority Council of F BiH was legally contested. The establishment of the Government based on the parliamentary elections has not been finished for four months after the elections, therefore the documents of National Minority Council have not been approved yet. The Council still does not have its premises, or basic financial resources for work (e.g. to cover travel expenses of representatives who are not from Sarajevo). The technicalities related to organization of the Council's sessions are done by the Commission for Human Rights and Freedoms with the Houses of the Parliament of F BiH.

In spite of all legal, financial and technical problems, the Council nevertheless held 7 sessions during 2010. We do hope that new legislative authorities will show more understanding and be open towards the European requirements regarding the respect of human rights and prevention of discrimination. We also hope that they will approve the Statute, Rules of Procedure and financial plan of the Council of National Minorities in F BiH, and resolve technical and other problems of the Council of National Minorities, and thereby facilitate its work.

CALEIDOSCOPE

Caleidoscope is a school project which was intended to encourage schools in BiH to explore culture, history and tradition of 17 national minorities in BiH. **On 8 December 2010 the OSCE Mission** to BiH announced the winners of the school competition about the national minorities.

The students from V to IX grade took part in the school competition titled Caleidoscope to which the schools applied with their projects about national minorities and joint heritage of the country. More than 100 projects were submitted to the competition from 1 April to 19 November 2010.

The representatives of 17 schools, students and teachers received awards for the projects about different approaches to learning about the national minorities. The number of winners symbolizes the number of national minorities recognized in BiH, that is 17.

The students of Second Primary School from Živinice took the first place, winning the award in the amount of 2000 EUR. The Sokolje Primary School from Sarajevo and the Branko Ćopić Primary School from Prijedor took the second and the third place, winning the awards in the amount of 1500 and 1000 EUR, respectively.

The Head of OSCE Mission to BiH, Ambassador Gary D. Robbins, stated at the awards presentation that all participants in the competition had learnt a

lot about their country. "By their participation and engagement in the school projects, you all learnt something new, developed your awareness and understanding of how rich and diverse in your communities are as well as this country" said Ambassador Robbins.

The representatives of the Ministry of Education, Pedagogic Institutes, embassies and associations of national minorities attended this event.

The Caleidoscope school competition, supported also by the High Commissioner for National Minorities of OSCE, will further encourage the schools to keep exploring the culture, history and tradition of 17 national minorities living in BiH.

During 2011 the total of 17 awarded projects will be presented across the country to demonstrate talent and creativity of students, and to encourage others to explore the rich diversity of BiH.

The members of the Panel for Selection of Caleidoscope projects, and for selection of three best works, were a member of the Council of the National Minorities with the Parliament of BiH, Jovanka Manzalović Šalaka, Leonard Vlenta – the author of "Manual for national Minorities in BiH" and Aida Premilovac from OSCE.
